### Foreword

#### As I reflect on another year passing, I've been blown away by the enormous positive impact #TeamKSBScot has had in inspiring environmental action across the country.

It has been fantastic to once again collaborate with communities, schools, businesses, local and national government, public bodies and individuals all over Scotland to inspire behaviour changes to improve our environment. The work carried out across the country is made possible by those who support and fund what we do, and by those who volunteer their time in the name of a clean, green and sustainable Scotland.

Our charity is a practical organisation working to combat climate change, tackle litter and waste, and protect and enhance places. We've been delighted to see many successes across the breadth of our activities and initiatives this year.

We declared a litter emergency after warning for many years that one was coming. We remain committed to tackling the issue and continue to be creative, launching new and innovative campaigns to encourage behaviour change and action.

# Training, assessments and awards

We support you to fulfil and exceed your environmental responsibilities with training, audits and assessments, and we celebrate your success with awards.



### Supporting Scotland to become climate literate

We have worked with partners in the private, public and third sectors to develop Climate Emergency Training specifically for the charity, energy, construction, transport, tourism, housing, and local authority sectors.



In partnership with Elevator UK, we delivered workshops and climate training to a range of businesses and communities across Scotland, as part of the Community Renewal Fund. We also delivered key projects with Skills Development Scotland and other partners including Scottish Council for Voluntary Organisations (SCVO), supporting the transition and upskilling required across Scotland's future and existing workforce to help key sectors respond to the Climate Emergency and transition to a net zero nation.



In collaboration with Green Tourism, and supported by Visit Scotland, we delivered a programme of training for Scotland's tourism sector. This increased understanding of climate change science and impacts and how the sector can use its actions and influence to respond to the climate emergency and contribute to Scotland's journey to net zero.

#### Assessing the cleanliness of Scotland and providing a framework for organisations to make environmental improvements

Our suite of environmental assessments and audits supports communities, organisations, and local authorities to improve local environmental quality and meet their environmental responsibilities.

The data and evidence that we collect to assess the cleanliness of Scotland assists us to develop and implement robust, evidence-based reports and campaigns, innovations and bespoke audit projects. This enables us to work in collaboration with a range of organisations to prepare for any environmental quality policy and legislative changes such as Extended Producer Responsibility schemes including deposit return and packaging.

In December 2022 we declared a litter emergency in Scotland in our updated report on local environmental quality.

- 9,109 individual sites audited through LEAMS to assess Scotland's cleanliness.
- Silver Ports and Harbours Environmental Award presented to CalMac and CMAL.
- 5-Star grading awarded to Wheatley Homes South as part of our ongoing partnership with the Wheatley Group.



#### Supporting Scotland to become a litterate country

The environmental training we offer covers a wide range of issues and supports people to develop the skills and knowledge needed to better understand the challenges our environment faces and to take positive action. In response to the litter emergency our training covering environmental quality legislation, conflict management and behaviour change has found renewed traction with local authorities and duty bodies.

- 40 training sessions delivered on topics such as LEAMS/LMS, Fixed Penalty Notices and Commercial Waste.
- 4 sessions of our innovative Litterate programme delivered to staff, elected members, and communities with Glasgow City Council.
- 75 delegates attended our LEQ Seminar which was hosted in-person for the first time since 2019.

#### The Wheatley Group

The Wheatley Group is Scotland's leading housing, care and property-management group, owning or managing over 93,700 homes across the country. We work with Neighbourhood Environmental Teams across Wheatley Homes Glasgow, South, and East to support these subsidiaries to achieve their annual Environmental Quality Standards by assessing and auditing sites, and granting awards based on environmental performance.

The awards are based on criteria set out in the National Award for Environmental Excellence<sup>®</sup> - a framework for continual improvement that recognises and awards best practice in environmental and carbon management as well as maintenance, waste management and community engagement.

Tenant Les Moffat says the new environmental service helps communities look their best. Les, a retired postman from Troqueer, Dumfries, said:

"The environmental teams have made a big difference.

I take part in walkabouts with Wheatley Homes South staff quite often, checking gardens and stairwells, making sure areas are kept clean and tidy. If there's anything needing done, they get it sorted.

My friend lives in Lockerbie and she says it's the same there – grass is cut, and areas are kept nice and tidy."

#### Nature and biodiversity

In partnership with NatureScot we delivered two Climate Emergency Training for Biodiversity and Nature workshops as part of their Nature Restoration Skills Week. NatureScot also sponsor the It's Your Neighbourhood Pollinator Friendly Award which encourages groups and individuals to make their space as pollinator friendly to increase biodiversity and reconnect with their environment.

We were successful in our application for SCQF funding to develop an accredited Biodiversity course, and look forward to launching this in the coming year.

### Celebrating our fantastic green and blue spaces

Through our awards we recognise and celebrate the best of Scotland's green spaces and beaches.

In 2022 we celebrated **30** years since the first two beaches in Scotland received awards to celebrate excellent environmental management. In recognition of consistent achievement over three decades we coordinated two celebration events, one at Gullan Bents in East Lothian and another at St Andrews West Sands in Fife – both winners of Scotland's Beach Award.

The number of parks and open spaces which achieved a Green Flag Award® increased again this year, with 16% being located within the most deprived 30% of the population. The number of Green Flag Community Awards rose by **3** to **12** this year too, highlighting the ongoing commitment from people managing their local green and open spaces.

- 53 beaches across 11 local authority areas awarded Scotland's Beach Award.
- Record 85 green spaces in 15 local authorities awarded Green Flag Award<sup>®</sup>.
- Scottish Green Flag Award<sup>®</sup> winning green spaces crowned winners at UK Best of Best Green Flag Awards in 4 categories.
- Strathaven Park named in Top 10 People's Choice award – the only Scottish site on the list.
- 93% of Scottish people willing or already taking action to protect their local beach, from My Beach, Your Beach campaign research.

#### Community Climate Action Plan

#### Climate Week 2022

Scotland's Climate Week took place in September 2022, and we were once again delighted to showcase our range of climate action initiatives and programmes. During the week we supported and engaged with a range of businesses, schools, communities and individuals to help them learn more about what they can do to combat climate change.

We delivered an Introductory Workshop on climate change to more than **100** participants which was attended by the Minister for Biodiversity, Circular Economy and Green Skills, Lorna Slater. And we supported the Scottish Government and the former Minister for Environment and Land Reform, Màiri McAllan to launch the updated Marine Litter Strategy.

Through our Schools Climate Action Week, we reached more than **15,000** pupils and launched our newly repositioned Climate Action Schools framework of education initiatives. We also supported our friends FEE to launch the Running Out of Time relay, carrying a message from young people at COP26 to World Leaders at COP27.

#### Keep Scotland Beautiful does Net Zero

We have proudly maintained the internationally recognised ISO14001:2015 Environmental Management System accreditation since 2016. Our ambition is to become a net zero organisation by 2030 and we have committed to undertake a full review of our environmental and carbon footprint in order to establish Science-Based Targets.

Our ambition includes maintaining our ISO14001 status and Platinum Carbon Literate Organisation accreditation. Over the past year we have supported our staff and Charity Trustees to become carbon literate and action the pledges made and will continue to do so as new members join our team.

Reaching net zero is an integral aspect of creating a sustainable future for us all. As an environmental charity, we lead by example, encouraging others to follow and learn from our transition to becoming a net zero organisation.

We work to support Scotland's 2045 net zero target through our awards, education and community engagement work, with the ambition for Scotland to become a climate literate nation.

## Campaigns and research

We raise awareness of the challenges our environment faces and gather evidence so that through innovative and inspiring campaigns, we can encourage people to rethink their behaviours and take positive action.

#### Addressing the journey of litter from source to sea

Our Upstream Battle<sup>®</sup> on the River Clyde began in 2018 with the aim of connecting people with a common goal – to stop litter ending up in the Clyde. In 2021 the Upstream Battle<sup>®</sup> campaign evolved as we launched on the River Tay to work with four council areas – Perth and Kinross, Dundee City, Fife, and Angus – to connect communities and work together to clean up the River Tay. This year we continued to work with volunteers to gather Citizen Science data, raise awareness, inspire action and work with children and young people to clean our rivers and protect our seas.

#### On the River Clyde

- 13 Anchor groups supported.
- 194 pupils engaged through 14 online workshops across seven local authority areas.
- 387 pupils involved in our Upstream Battle<sup>®</sup> school visits.
- We welcomed former Minister for Environment and Land Reform, Màiri McAllan to our STEM the Flow Engineering Challenge.
- 608 pupils reached at 124 schools through our STEM the Flow initiative.
- 326 young people involved in our Upstream Battle<sup>®</sup> Marine Litter Art Competition.

#### On the River Tay

- 9 Anchor groups supported.
- **28** litter surveys completed along the river.
- Supplied litter picking equipment to Anchor Groups supporting them and others who wished to get involved.
- 30 businesses attended our breakfast briefing alongside Dundee and Angus Chamber of Commerce to encourage further engagement with the campaign.
- 100+kg litter collected in just one week on the Tay.

#### **Tackling the litter** emergency

We launched our partnership with behaviour change app LitterLotto in October 2022. The app incentivises people to bin litter and in the first six months of our campaign we've had winners of all ages from Wick to Ayr including those who have always picked litter, and those who have started as a direct result of our partnership.

- 21 winners across 12 local authority areas.
- **£5,650** given in prize money.
- 109,667 pieces of litter recorded as binned through the LitterLotto app.
- South Ayrshire Council became the first in Scotland to partner with us and LitterLotto.



#### Protecting sand and sea

Our My Beach, Your Beach campaign has raised awareness and helped people care for our beaches and bathing waters - our sand and sea - since 2018. The campaign focused on education and behaviour change interventions to support bathing water quality improvements and beach stewardship through the promotion of simple messages and actions to protect sand and sea. The seven beaches - Saltcoats/Ardrossan, Irvine, Troon, Ayr, Portobello, Fisherrow Sands, and Kinghorn – were chosen because of high footfall and a history of bathing water quality challenges.

- 24 entries and 331 votes for our #DoggyAmbassador campaign which had a social media reach of 67,315.
- **74** litter surveys and **717** perception surveys completed.
- Hosted beach cleans at South Beach Ardrossan, Fisherrow Sands and a silent disco litter pick at Portobello Beach.
- 4 businesses signed the pledge to commit to at least 3 activities to support our campaign.
- **8** of Scotland's Beach Award winners piloted My Beach, Your Beach campaign messaging across 5 local authorities.

#### Inspiring community-led waste reduction in the Highlands

We coordinate the Highland Community Waste Partnership, which brings together eight community groups in the Highlands to tackle waste and to promote more sustainable consumption across the region. Our work is focused on three key strands of waste: food waste; single-use items and packaging; and promoting sharing and repairing, as an alternative to throwing away and buying new. We aim to create change through a combination of communications and engagement, workshops and events, and more targeted projects and interventions, with each partner leading on different activities, based on their experience and expertise.

We secured funding for Cup Movement<sup>®</sup> in the Highlands, which aims to remove barriers to reusable packaging in the hospitality industry, through the Starbucks<sup>®</sup> and Hubbub Bring It Back Fund. We developed this project by conducting research in the Highlands and will be delivering it in collaboration with North Coast 500. Zero Waste Scotland and the Highland Good Food Partnership. The project comes at a vital time as we know 82% of people surveyed in the Highlands are concerned about the amount of single-use takeaway cups used. We have **25** businesses signed up to the scheme which will run until the autumn along the NC500 route.

- 102 workshops and events, engaging 845 people across the Highlands.
- 1,200+ items saved from landfill, through nearly 70 sharing, repairing or upcycling events and workshops.
- 116 composters given out in Lochaber and around 12 tonnes of food waste estimated to be diverted from landfill each year as a result of our composting workshops.
- Over **700** hospitality businesses encouraged to reduce their food waste, in collaboration with Zero Waste Scotland.
- 4 Climate Emergency Training courses delivered to Youth Climate Advocates in the Highlands.

## Tackling litter and waste

**The issue:** There is a litter emergency.



Our ambition: Scotland is litter free and has a circular economy.

We provide support to help prevent and clean up litter, maintaining greener, cleaner and healthier places across Scotland.

In December 2022 we declared a litter emergency in Scotland. Litter is a matter of significant public concern as highlighted in our annual public perception report the Scottish Litter Survey produced in association with the Diffley Partnership. This deterioration in standards is also evidenced through the data we collect and is detailed in our updated report Time for a new approach: tackling the litter emergency.

Ahead of Extended Producer Responsibility (EPR) schemes coming into force, we have aligned our LEAMS data monitoring and measuring categories to capture data relating to Scotland's Deposit Return Scheme and other EPR measures.

#### Partnership working to improve environmental quality

A central value of our vision and mission is to work collaboratively. We work in strategic partnership with a number of organisations towards improving the quality of Scotland's environment. Together with Scottish Government and Zero Waste Scotland we have input into development of the new National Litter and Flytipping Strategy, following our facilitation of a number of consultation events in early 2022.

LEAMS scoring is a key performance indicator for local authorities, allowing tracking of progress in street cleansing. With two-thirds of authorities seeing a drop in their scores, it is clear that this is a national problem. We produce reports to help local authorities improve their performance. Since 2019/20 we have also been working with Zero Waste Scotland to transition to using LMS, a new system where surveys can be collected spatially and analysed online.

In collaboration with Keep Wales Tidy, we were chosen to take part in an Alan Turing Institute data challenge. The project aims to understand if artificial intelligence (AI) can be used to analyse images of litter and improve data collection during litter surveys. In addition, two collaborative projects with the University of Stirling Management School will be scoping how AI can be best utilised to collect environmental data and how information can be analysed and presented to best inform services.

These projects will help improve our knowledge of different methods of data collection and how we can improve efficiency in monitoring litter, as well as improve the way we, and other stakeholders, use data to tackle this growing issue.





#### Single-use vapes

Recently we have seen a new and unnecessary contributor to the litter emergency: single-use vapes. These vapes undermine the principles of a circular economy and their components end up in our environment when not recycled. In partnership with Green Alliance, ASH Scotland and Marine Conservation Society, we wrote to the relevant UK Government Secretaries of State highlighting the environmental impacts of disposable vapes. Additionally, we also called on the Scottish Government to ban the sale and manufacture of single-use vapes in Scotland, and called for all Scottish retailers to stop the sale of single-use vapes. Alongside environmental activist Laura Young, we encouraged everyone to fully support the Scottish Government's planned evidence review into single-use disposable vapes and their impact on the environment.





#### **Circular Economy principles**

We submitted responses to both the Circular Economy Bill and the Route Map consultations in which we reiterated our support for a circular economy for Scotland. Addressing the consumption of goods is vital in tackling the crises of climate and biodiversity, as well as the looming litter emergency.

The way that we consume goods and services needs to change. This means that we need to change up the way we buy, use, and dispose of things – something that is being addressed through the Highland Community Waste Partnership that we coordinate, and through Cup Movement<sup>®</sup> in the Highlands.

By getting better at repairing, sharing, and passing things on we can keep items in use for longer, reducing new items being bought and thrown away. Circular economy legislation is expected soon for Scotland, and we will continue to play our role in driving the transition to a circular economy.





#### Single-use items

An important part of achieving a circular economy is eliminating unnecessary single-use items. We have continued to campaign and advocate for a reduction in consumption of these items through our policy and influencing work, and through our support of targeted external campaigns. In 2022, we supported Scottish Water's Nature Calls campaign to call for a ban on plastic containing wet wipes and celebrated the introduction of the single-use plastics ban in Scotland – The Environmental Protection (Single-use Plastic Products) (Scotland) Regulations 2021.

We are members of a range of formal and informal groups seeking to eliminate unnecessary single-use items including: the Scottish Government's Single-Use Disposable Cup Charge Advisory Group; Secretariat for Cross-Party Group on Circular Economy alongside Fidra, Marine Conservation Society and Scottish Environment LINK; a range of working groups through our membership of Scottish Environment Link; on a UK-wide basis with our sister organisations in England, Northern Ireland and Wales.



## Community engagement

We support you to fulfil and exceed your environmental responsibilities using bespoke audits and assessments, and we celebrate your success with awards.





#### Supporting community climate action

We continue to build on our decade long commitment to delivering community climate action across Scotland and have worked with 10 communities across the country to develop and implement community climate action plans.

Through the Highland Community Waste Partnership, we've also worked with people across the Highlands on a programme of Climate Emergency Training for Youth Climate Advocates, accrediting 10 young people as carbon literate, and encouraging them to get involved in, and inspire, climate action across the region.





#### Championing communities to protect and enhance the places that matter to them

During 2022, Canal College® provided people of all ages from Falkirk communities with the opportunity to learn heritage skills in a fun, safe and engaging environment as part of the Falkirk Canal Connections project funded by UK Government. Participants collaborated with professionals and community organisations on a unique range of activities including archaeology, canal maintenance, woodland management, conservation and traditional skills. They developed new skills and made friends while achieving a range of awards and gualifications. Many moved on to positive destinations including employment, college courses and further volunteering opportunities, and most participants reported a general uplift in confidence, wellbeing and positivity about their future as a result of taking part.

The SQA Cultural Heritage Award consists of seven units and covers topics including conserving and recording heritage assets, guided tours and exhibitions. The full seven-unit SQA Award was granted to 12 participants.

#### Inspiring environmental action in neighbourhoods across Scotland

We recognise and celebrate the work of communities across Scotland who take pride in their local neighbourhoods and work to improve and enhance these spaces leading nature and climate friendly places. Our environmental improvement initiatives It's Your Neighbourhood and Beautiful Scotland run in partnership with the Royal Horticultural Society and encourage communities to take pride in their local neighbourhoods.

- 166 groups assessed for It's Your Neighbourhood; **46** groups took part in Beautiful Scotland.
- 176,364 hours committed by volunteers to improve their neighbourhoods.
- 2,064 hours committed by voluntary assessors and judges to support and provide advice.
- **28** community events facilitated across the It's Your Neighbourhood and Beautiful Scotland networks.
- 29% of community groups across the It's Your Neighbourhood and Beautiful Scotland networks are located within SIMD Decile 1-3 Areas.
- **105** people volunteered their time to assess and judge our environmental improvement initiatives and awards.

#### Addressing the litter emergency through community action

Clean Up Scotland is our initiative to tackle litter. Through this work we raise awareness of Scotland's litter problem, take action, and inspire others to do the same. Every year we also run a targeted monthlong Spring Clean which sees thousands of volunteers roll up their sleeves and organise litter picks up and down the country.

To tackle the litter emergency, we have worked with communities across Scotland. We now have 146 Community Clean Up Hubs across **30** local authority areas in Scotland. The hub groups, positioned across rural, coastal, and urban areas, have been provided with training, guidance and litter picking equipment to help them support the wider community with litter picking activities. We've also supported various litter clean up across the country, including with Royal Bank of Scotland plc. Board members who collected 59 bags of litter at Sighthill Park in Edinburgh and Decathlon staff at a number of events.

- **24,023** people involved in Clean Up events across Scotland. Of these, 15,330 were young people.
- **216** litter surveys carried out by the Clean Up community.
- Almost 600 events hosted.

Last year across Scotland, volunteers involved in It's Your Neighbourhood and Beautiful Scotland contributed almost 200,000 hours of their time, equating to an economic value of over £2.5 million. These volunteers make a real difference to their local areas, improving the quality of the places they take pride in and enjoy by increasing biodiversity and beautifying their neighbourhoods. In addition, volunteers took part in our heritage work, with their time helping to conserve and enhance the built, natural and cultural heritage of Scotland.

#### **Climate and nature** friendly places

Alongside focusing on climate action, it is important that we take positive steps to protect and enhance biodiversity across Scotland. Communities make a huge contribution to the vital work being done to tackle the climate and nature emergencies we are facing, helping make Scotland clean, green and sustainable for people and planet. We have been honoured to hear about the work of 200 groups across Scotland through network updates, at our online quarterly sessions, and during the 13 Beautiful Scotland regional celebration events we attended to present certificates and trophies. Our work to support communities become more climate and nature friendly has included offering Climate Emergency Training to our volunteer judges and assessors.



#### Best of Best UK Green Flag Awards<sup>®</sup>

Green Flag Award<sup>®</sup> winning parks and greenspaces from across Scotland were recognised at the UK's Best of the Best award ceremony in November 2022. Scottish awardwinning parks from Aberdeen City, Falkirk, and Scottish Borders were represented in **5** out of the **9** categories.

Zetland Park in Grangemouth, Falkirk Council won 2 categories; Best Celebration Event for the grand re-opening of the park following the completion of a large-scale regeneration project, and Best Climate Change Adaptation for their Rose Garden Raingarden which demonstrates the benefits of nature-based solutions for people and nature living in towns and cities, and was co-designed with a local community action group.

### Placemaking through heritage

The Placemaking Through Heritage project, funded by Historic Environment Scotland, provides a multi-faceted, community-based approach to heritage engagement and action. We have supported a wide variety of activities according to need and interest, such as qualifications in cultural heritage, exhibitions about local history, development of new interpretation panels, surveys of local buildings and gravestones for inclusion in the national record.

In our third and final year of the project we have worked with the residents of Cumbernauld Village and Twechar, community growing groups, university students undertaking their teacher training, school pupils and a charity supporting people with addictions. In June 2022 we worked with primary schools in Edinburgh to celebrate the 200th anniversary of the Union Canal.



### **Climate Action Schools**

We provide education initiatives for children, young people and educators which focus on environmental issues. We increase climate change awareness, enable young people to have a voice and take action on issues that matter to them and embed Learning for Sustainability across Scotland.





#### Launching Climate Action Schools

Climate Action Schools is our framework of education initiatives designed to support Scotland's educators, young people and children to progress Learning for Sustainability and climate change education and is inclusive and accessible to all. It includes the internationally recognised Eco-Schools programme, our accredited Climate Ready Classrooms programme, and supports Curriculum for Excellence from early years to senior phase.

- 1,694 schools involved in Climate Action Schools activities.
- 2,505 Climate actions pledged.
- **835** active Eco-Schools.
- 54% increase in first time applications to Eco-Schools.
- 876 young people accredited as Carbon Literate through Climate Ready Classrooms.

#### **Education at a glance**

This year we aimed high. We reached more pupils and inspired more environmental action. Each school participating in activity linked to our Climate Action Schools framework commits to link their work to one of the UN Sustainable Development Goals, helping to drive Scotland's progress on sustainable development.

- **36,000** participants in live lessons.
- 876 young people, 48 educators accredited carbon literate.
- 1,694 schools involved in Climate Action Schools activities.
- **2,505** climate actions pledged.
- 54% increase in first time applications to Eco-Schools

#### Developing capacity and capability to support environmental education

Through our work with schools over the past two decades we heard from teachers and young people that they needed more help to understand the facts, the challenges ahead and the links between what they were doing and how it helped tackle the twin climate and nature crises.

In response to this we developed a programme of Professional Learning, including twilight sessions and announced a Scottish Credit and Qualifications Framework (SCQF) Level 4 course aimed at secondary school pupils looking to develop their knowledge of climate change and understand what positive decisions they can take to address the causes of climate change.

- 8 STEM the Flow Upstream Battle<sup>®</sup> Career-long Professional Learning sessions.
- 12 Dandelion twilight sessions run covering 6 topics.
- 13 Eco-Schools Scotland sessions delivered reaching 265 educators.
- 22 certificates awarded from first SCQF accredited Climate Emergency Training course.
- 40 pupils currently trialling new SCQF course.
- 925 pupils attended Eco-Schools Scotland training workshops.

### Developing partnerships to deliver live lessons

Our partnership with the Royal Zoological Society of Scotland and the Scottish Book Trust has allowed us to develop a broad range of interesting and interactive learning opportunities for young people. In collaboration with a variety of people and organisations working across Scotland on topics such as reptile and amphibian conservation, eco-journalism, globally important geology, storytelling, the importance of keeping our streets clean, and climate and biodiversity action, we've reached and inspired schools across all of Scotland's local authorities.

- 12 external partners engaged.
- 4,148 classes registered to take part in Live Lesson activities.
- **36,000** participants engaged across **28** Live Lessons online sessions.

#### Supporting young people to contribute and amplify their voices

Developing the skills for learning, life and work are central to Curriculum for Excellence, and are core to the work that we do. Pupil-led engagement and amplification of the pupil voice therefore underpin all our education programmes and activities.

Climate Action Schools provides opportunities for learners to contribute their voice to decision-making that shapes their education through activities such as the Eco-School Committee aspect to the Eco-Schools programme, an activity that can influence the whole-school approach to Learning for Sustainability through the environmental issues or topics identified by pupils.

A further example of amplifying the pupil voice is the international Young Reporters for the Environment (YRE) programme that sits within the Climate Action Schools framework. YRE is an environmental journalism programme designed to give young people the opportunity to share their thoughts on environmental issues they feel strongly about through writing, photography, and videos.



### Bringing biodiversity into the classroom

We delivered the schools programme of Dandelion – a large creative programme encouraging people to sow, grow and share food, music and ideas across Scotland. As part of this, we explored community and cultural connections to land and food with schools which resulted in pupils sowing **258,000** potatoes.

Our popular Pocket Garden competition received nearly **16,000** votes in the search for a winning garden design. The competition encourages children and young people to get involved in growing activities. The Biodiversity and COP15 themed live lesson featured a pre-recorded address from the Minister for Biodiversity, Circular Economy and Green Skills, Lorna Slater.

We launched the Learning about Forests (LEAF) pilot supporting outdoor learning in Scotland through hands-on experiences and helping pupils gain a deeper understanding of the natural world.

- **150** entries to 'craftivism' competition.
- 340 Pocket Garden entrants across 28 local authorities.
- 55 schools piloting LEAF across 21 local authorities.

As we work towards combatting climate change and tackling litter and waste, we know that big challenges remain. In addition, changes in policy and legislation will bring their own challenges as Scotland transitions to becoming a nation that has a circular economy and reaches net zero.

To overcome these challenges, we all need to be more aware of how the actions we take impact on the environment, and how this impact can be reduced. This is increasingly true for many organisations and businesses who have yet to fully prioritise and implement adequate environmental management systems or action plans to minimise – as far as is possible – their environmental impact.
