The issue: There is a climate emergency.




Our ambition: Scotland is a net zero nation.

We're supporting Scotland to become climate literate. Our three-year strategy outlines the three ways we will inspire and support action to combat climate change:



Lead on, and increase, climate action in schools:

Having refocused our education programmes and activities under the banner of Climate Action Schools, we have supported the increasing demand from schools across the country to help children, young people and educators continue to take positive action for our climate through our activities and training which help people understand the challenges and opportunities.








Develop and deliver more accredited Climate Emergency Training to all sectors of Scotland:

We have increased our portfolio of accredited Climate Emergency Training courses, offering more than **10** bespoke packages for sectors across Scotland, as well as our introductory sessions and quarterly open course. We now offer training for the sport sector, and for rural industries through our partnership with SAC Consulting.

Climate Action in Sport

Tackling litter and waste



The issue: There is a litter emergency.



Our ambition: Scotland is litter free and has a circular economy.

We're supporting people to clean up Scotland. Our three-year strategy outlines the five ways we aim to inspire and support action to tackle litter and waste:



Deliver our commitment to the **National Litter and Flytipping** Strategy:

Since the publication of the Scottish Government's National Litter and Flytipping Strategy in June 2023, we have been a key delivery partner of the Year 1 2023/24 Action Plan. We led on engaging and empowering communities through the creation of an online Community Litter Hub and new litter education programme, developing and testing innovative interventions to tackle littering behaviours and collecting and analysing litter data to support improvements in line with the Data Strategy.

53 people attended Community Litter Workshops across 5 events.

Maintain existing and introduce new reuse and recycling behaviour programmes and campaigns:

We entered year two of our Highland Community Waste Partnership, launching the Conscious Consumption Campaign. We delivered Cup Movement[®] in the Highlands and worked with retailers in Dundee and Glasgow to increase singleuse cup recycling through Take It Back.

Increase engagement in litter picks and survey activity:

Upstream Battle[®] and Spring Clean Scotland, our two flagship litter campaigns, inspired volunteers in every area of Scotland to get involved in litter picks, raising awareness and collecting data.

> **30,000** people carried out litter picks during Spring Clean Scotland 2023.

200+ surveys returned as part of our Upstream Battle® campaign.

280 tonnes of litter collected during Spring Clean Scotland 2023.





Develop and carry out bespoke, consistent and valued audits and data analysis:

In November 2023 we published two litter reports – Scottish Litter Survey and How clean are our streets? - which tracked public perceptions and attitudes towards litter and littering behaviour as well as reporting on our ground litter data which highlighted litter items which could be reduced if a Deposit Return Scheme or Extended Producer Responsibility regulations were implemented.

Increase number of communities engaged in our growing programmes:

We remain committed to supporting the amazing groups across Scotland who are working tirelessly to restore nature and biodiversity and improve their communities.

8,514 votes were cast by the public to choose the public's favourite winning Pocket Garden design.

Engage more schools in practical programmes to reconnect young people with nature:

We continue to support Scotland's young people to get involved with nature, connecting them to international programmes which we deliver on behalf of the Foundation for Environmental Education (FEE).

<u>4</u>3 schools entered 2023 Pocket Garden competition, with 8,514 votes deciding the winner.

11,509 pupils involved in our national Learning about Forests (LEAF) programme.

Deliver more training to develop understanding and inspire action at a local level:

Our new Biodiversity Action SCQF course for secondary schools has been accredited and we are working with four schools and around **40** pupils. Expressions of interest have come from **46** schools across **21** Scottish local authority areas for future delivery.

Our Climate and Nature Training, accredited by the Carbon Literacy Project, has been delivered to volunteers and is one of more than **10** types of Sector-Based Accredited Climate Emergency Training we now offer.



Provide a greater number of organisations and businesses with training to enable them to become nature positive:

Our training is always tailored to the Scottish context, and often we work with clients to ensure it is bespoke and relevant to their priorities and audiences. We have developed and launched a new Nature and Biodiversity training course to help individuals and organisations understand the value of nature and biodiversity, reasons behind its decline and how to support the recovery of habitats which will benefit planet and people.

Improving places



The issue: The quality of our places and spaces is declining.



Our ambition: Scotland's places and their heritage are restored.

We're supporting people to improve our local communities. Our threeyear strategy outlines four ways we aim to inspire and support action to improve places.



Grow the number of volunteers and communities taking action:

We established our Climate and Nature Friendly Communities Network, a connected umbrella for our community groups to support and celebrate each other. Our various initiatives and campaigns support people to get involved with tackling the combined litter, nature and climate emergencies. 146 Clean Up Hubs supported across Scotland.

253 groups involved in Beautiful Scotland and It's Your Neighbourhood activities.

2,600 pupils participate in first #SpringCleanScotland Litter League, collecting 870 bags of litter at over 100 clean ups in 23 local authorities.

425,000 pieces of litter binned through LitterLotto with winners from 14 local authorities.



Increase partnership working at a local level, engaging businesses in placemaking:

Developing our people and organisation



Our ambition: We have the capacity to lead

change and respond quickly to environmental issues.



We are a Net Zero and sustainable organisation.

Our three-year strategy outlines six ways we aim to inspire and support action to develop our people and organisation:



Support our team with training and development opportunities.

Investing in #TeamKSB is key to ensuring that we run our charity the best way we possibly can, supporting the development needs and wellbeing of our team. Our hybrid working policy, piloted the year before, was formally adopted, giving employees the chance to work from home or in our Stirling hub.

We have worked to revise **32** policies and procedures to support our work, as well as refreshing our employee handbook and establishing a Menopause Working Group.

First Aid training, Fire Marshal training and IOSH training was provided to members of #TeamKSB during the year, ensuring we minimise risks and help employees stay healthy and safe.

During the year we were also able to support five internships across the organisation, four through Graduate Career Advantage Scotland and one with Inclusion Scotland. We also facilitated two University of Stirling students to undertake dissertation projects on marketing and data.

We became the first organisation in Scotland to achieve Platinum status as a Carbon Literate Organisation and remain the official partner in Scotland for the Carbon Literacy Project.

Achieve our Net Zero ambition

We reaffirmed our commitment and ambition to transition to net zero by 2030. Work to monitor and calculate our new and updated baseline footprint is well underway.

Net Zero Transition Plan will be fully updated and published in the first quarter of 2024/2025. We will continue to gather data as accurately as we can, going deeper into Scope 3 emissions, including commuting and homeworking, tackling the areas, particularly travel, where we can realise most impact and make the biggest carbon reductions. Additionally, we have committed to review our banking and pension arrangements.

We continue to encourage others, including our suppliers, to consider their impacts and make changes where possible.



"I'm currently in my third year studying Environmental Management at university. During my internship I have learnt how invaluable it is for the workplace and people I work with to know I am deaf before starting a job in that space. Invest in our IT infrastructure and online services

In order to ensure that we meet current cyber security standards and insurance requirements we have moved our public facing online services to a new cloud hosting service and replaced our physical firewall unit at our Stirling Hub. Additionally, these actions will result in future cost and carbon savings.

In 2024 we implemented Multi-Factor Authentication (MFA) for all users and guests on our IT systems, allowing us to comply with best practice cyber security and data protection measures.

We continue to make progress on our ICT roadmap with our IT working group, and our future plans include migration of our onsite servers and data to the cloud and continued development of our website content management system.



Ensure strong financial management systems are in place:

We have continuously refined and improved our monthly financial management reporting over the year and our annual external audit confirmed we have robust systems in place.

Build on our EFQM and ISO 14001 management standards

Our work to ensure we do as much as possible to make our organisation as sustainable as possible continues.

We successfully met the ISO14001 standard at our annual external audit and maintain our certification.

Our commitment to organisational development and standards continues as we review our EFQM ambitions, and we remain a Living Wage Employer.





Enhance our governance standards

We pride ourselves in being a charity which continuously works to improve our standards of governance and management. This year we completed our Governance Review in line with Scottish Charity Regulator (OSCR) guidance and charity law.

Our Chair also conducted one-to-ones with all Charity Trustees to ensure that the governance remains inclusive and provides appropriate challenge to the Executive team.

We are supportive of the current reforms of Charity Law and support any improvements which builds confidence of the public in our work.



Collecting more data, utilising state of the art technology and citizen science, to evidence the urgent need for improved policy, regulations, and legislation to improve our environment.


Broadening and deepening our reach and support to young people, communities and businesses so our campaigns, awards, training and activities continue to inspire action.
